\*The cost involved in any field trips planned by teachers of the school will be the responsibility of the family and is not included in the cost of tuition. Teachers will inform students about any class trip cost at the time they are planned and have a signed permission slip by the parent and/or guardian.

\*A cleaning fee of \$300 will be assessed to each family that does not participate in summer cleaning. Each family is required to participate for at least a 2-hour period.

\*Please note that the full cost of education also depends not only on tuition, but also on fundraisers, donations, contributions, etc. Any assistance in these areas is deeply appreciated.
